

IMPORTANT NOTICE

ACKNOWLEDGEMENT, WAIVER AND GENERAL RELEASE OF CLAIMS

By visiting St. Supéry Estate Vineyards and Winery and/or participating in a wine tasting, and in consideration of St. Supéry allowing me to visit the winery and/or participate in a wine tasting, I hereby acknowledge and agree to the following:

- I acknowledge the contagious nature of the COVID-19 virus and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by visiting or participating in wine tasting at St. Supéry, Inc. dba St. Supéry Estate Vineyards and Winery (St. Supéry) and that such exposure or infection may result in personal injury, serious illness, permanent disability or death.
- I understand that the risk of becoming exposed to or infected with COVID-19 at St. Supéry may result from the actions, omissions, or negligence of myself and others, including but not limited to St. Supéry, St. Supéry's employees, agents, service providers, and/or other St. Supéry visitors.
- I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself, including, but not limited to, personal injury, illness, disability, death, damage, loss, claim, liability, or expense, of any kind, that I may experience or incur in connection with my visit to or participation in wine tasting at St. Supéry ("Claims").
- To the fullest extent permitted by law, in consideration for being permitted to visit St. Supéry and/or participate in wine tasting, I, on behalf of myself, my heirs, executors, administrators, predecessors, successors and assigns, hereby release, discharge, covenant not to sue, and hold harmless St. Supéry, its affiliates, and its and their respective owners, principals, officers, directors, employees, agents, service providers, and representatives, of and from any and all Claims, including, but not limited to, all liabilities, claims, actions, damages, costs or expenses, including but not limited to, attorneys' fees and costs, of any kind arising out of or relating thereto.
- I understand and agree that this release includes any and all Claims based on the actions, omissions, or negligence of St. Supéry, its employees, agents, service providers, representatives and/or visitors, including, but not limited to, any and all Claims involving COVID-19 infection occurring before, during, or after my visit to or participation in wine tasting at St. Supéry.

- I am not aware that I have any health conditions that are known to increase my likelihood of experiencing injuries or make me more susceptible to illness while engaging in this activity.
- I acknowledge and agree to take appropriate precautions, including, but not limited to, maintaining good personal hygiene, including, but not limited to, frequent hand washing and sanitizing and staying at least six feet away from persons not in my party or related to me, other than St. Supéry hospitality personnel. In addition to following all precautions established by St. Supéry I will take all steps necessary to reduce the risk of illness to me and my party.
- I further acknowledge that I have neither been diagnosed with COVID-19, nor am I experiencing any symptoms of COVID-19 identified by the Centers for Disease Control and California Department of Health and have not had a fever or felt feverish without the use of medication, prescription or over-the-counter, in the last 72 hours.
- I also acknowledge that to the best of my knowledge I have neither been exposed to anyone who has been diagnosed with COVID-19, nor anyone who has shown symptoms of COVID-19.
- I further agree to indemnify St. Supéry, its affiliates, and its and their respective owners, principals, officers, directors, employees, agents, service provider, and representatives, from any and all claims arising out of my acts or omissions while visiting or participating in wine tasting at St. Supéry.
- I forfeit all right to bring any and all claims against St. Supéry, its affiliates, and its and their respective owners, principals, officers, directors, employees, agents, service provider, and representatives for any reason, to the fullest extent permitted by law. In return, I will be permitted to visit and participate in wine tasting at St. Supéry. I will also make every effort to follow all safety precautions posted and as explained to me verbally. In addition, I will ask for clarification when needed.
